### OCHS Queries Norby on Public Funds Find

CHUGIAK: The OCHS Committee is investigating a contract executed between the State Board of Education ion and the Anchorage Independent School District.

This fact was brought to light at a meeting of the Executive Committee at the home of publicity Chairman Bill Lowe, on Monday evening on August 21, 1961.

The contract allegedly commits all funds claimed for out-of-district students under Public Law 815.

The committee has sent an official inquiry to Dr. Theo Norby, Commissioner of Education,

### RE-APPORTIONMENT UNLIKELY TO AFFECT CHUGIAK

ANCHORAGE: George Allen of Chugiak, who attended a public hearing of Gov. Egans Reapprotionment Advisory Board at the Loussac Library, Monday stated that it was unlikely that the Chugiak area would be affected by any re-district ing.

Allen told the group that he did not feel that the residents of the Chugiak area had been sufficiently adviced on the subject, and felt that he as an individual was not in any position to speak for the community.

Since the final report is not to be submitted to Gov. Egan before the 19th of September, Allen felt that the

FORGIVE US OUR TRESPASSES !

Each year as hunting season comes, Alaskans are discovering changes that have come over some of their favorite hunting areas.

That last year may have been trackless wliderness, may this year have suddenly become part of a homestead and be hristling with "No Trespassing" signs.

Many hunters resent this being excluded from what they have considered their own private hunting grounds, and go after their moose anyway, regardless of the signs.

Here comes the unpleasantness. The mesteader has every right to post his land and keep hunters away. Any moose that happen to be on his land he regards as his moose, and in some cases unhappy hunters have discovered that a determined homesteader can legally lay claim to a moose shot on their land and have actually confiscated the meat.

Therefore, inconvenient as it may be, hunters must begin going farther and farther away from local areas to find unposted hunting grounds.

Eany of the local farmers and homesteaders here and in the Matanuska Valley have indicated that this year they will be playing for keeps, and intend to prosecute all trespassers to the full extent of the law.

It therefore behoves all hunters to remember this when they are tempted to ignore to those "No Hunting" signs.

COOK FOR AUGUST SUE AUBREY

This recipe is for the housewife who would like to treat her family to fragrant homemade bread, but dislikes the task of kneading the dough.

This high, crusty, eventextured loaf is extra moist, and does not require even a hint of kneading.

### STREAMLINED WHITE BREAD

1 cups warm (not hot) water

1 pkg dry yeast

2 tbs salt

2 tbs soft shortening

2 tbs sugar

3 cups sifted flour

DISSOLVE yeast and water in mixing bowl

ADD shortening, salt, sugar and half of flour

BEAT for 2 immutes at medium mixer speed, or 300 strokes by hand

SCRAPE sides and bottom of bowl frequently

ADD remainder of flour BLEND with spoon until smooth SCRAPE batter from sides of bowl

COVER with cloth
LET rise in warm place (85°)
for about 30 minutes

BEAT batter about 25 strokes and spread in greased loaf pan SMOOTH top and pat into shape

with floured hand

ALLOW to rise until batter reaches % inch from top of pan (about 40 minutes)

BAKE 375° oven for 45 to 50 min REMOVE from pan

PLACE on rack

BRUSH top with melted butter or shortening (yield 1 loaf)

TEX EXEMPTION FOR NATIONAL GUARD EMPLOYEES

WASHINGTON DC: Representative Raplh J. Rivers (D- Alaska) has introduced a bill to amend the internal Revenue Code of 1954 to exempt from taxation cost of living allowances received by caretakers and clerks employed by the National Guard outside of the continental United States or in Alaska.

The Legislation is designed to correct a situation which developed with statehood for Alaska whereby National Guard employees were not granted the tax exemption on their cost of living allowance as were other federal civilian employees.



The date of this meeting will be announced. Henriches also asked that anyone who has failed to fill out their CD questionaire be sure to do so.



Total aid in the first six months of 1961 was \$329,994 and the rate has risen sharply since July 1. Especially in need, according to Johnson, are the babies and small children.

He described the Marienfields refugee centeb in West Berlin as crowded with young parents with babies in their arms, reflecting the large number of "t refugees in their twenties and thirties. "Most had to flee," their babies."

CARE Executive Director Richard W. Reuter said contributions comed to cover the cost of relief distributions. They should be marked "Berlin refugees."


