TOW-TRUCKS STAND BY TO AID MARCHING MOTHERS

TRUCK CRASHES THROUGH STORE FRONT

EAGLE RIVER: Clint Hollevoet, of Anchorage, driver for the Sunrise Bakery was injured last Wednesday in a freak accident at the Eagle River Shopping Center.

Hollevoet was just approaching the door of the Market Basket with a load of bread which he was delivering, when the Arden's Dairy Truck came crashing through the plate glass door knocking him down.

Apparently the driver of the truck (which was backed up to the curb in front of the Market Basket) had the truck in reverse gear, when his foot slipped off the clutch causing the truck to jump the curb and crash through the door.

Hollevoet, was taken to the office of Dr. Marshall Simpson in Eagle River, where he was treated for injuries to his arm.

Damages at the Market Basket were limited to the broken glass in the door.

MOLDED TOMATO-CABBAGE SLAW

1 envelope unflavored gelatin
2 cups tomato juice
2 cups shredded cabbage
1 tbs lemon juice
Salt, pepper & other seasonings to taste.

SOFTEN gelatin in 1/2 cup tomato juice

NATIONAL REA URGES EKLUTNA STUDY

WASH. D.C: The National Rural Electric Cooperative Association, at its annual meeting this fall endorsed a number of resolutions among which was one concerning the Eklutna power facilities in Alaska, according to U.S. Senator Ernest Gruening.

The resolution stated that "we urge the Secretary on the Interior to re-study the wholesale power rates to preference users utilizing the Eklutna power facilities in Alaska as current returns indicate pay-out in 33 years instead of 50 years."

YOUTH UNINJURED WHEN CAR FLIPS

FIRE LAKE: Gordon McCrary Jr. of Eagle River escaped injury when the car he was driving skidded over the steep embankment opposite the Fish Hatchery Road at mile 15 1/2 last Sunday.

Young McCrary told the State trooper that he saw what appeared to be a car stalled in the road ahead and applied his brakes to avoid hitting it. Although McCrary attempted to steer his car into the ditch on East side of the road, he bounced off the bank and went over the embankment on the opposite side.

on a Mutual Aid agreement, and it is the responsibility of the Fire Company of each particular area to decide whether or not they will require assistance in extinguishing the fire.

He cited a recent example where well meaning individuals summoned both of Fire Companies, only to have one turned back by the State Police because their services were not required.

ARMY ASKS FOR EKLUTNA LAND WITHDRAWAL

FT. RICHARDSON: United States Army, Alaska has filed for withdrawal on a small tract of land at the head of Eklutna Glacier.

Army Officials said the site is required for training operations and will be utilized by small unit operational exercises during mountain and glacier training.

The area selected contains 68 acres which is the minimum for this type of training operation.

The withdrawal filed December 12, 1962, is in accord with the policy of the Commander in Chief, Alaska to withdraw only land actually required to successfully perform the military mission in Alaska.

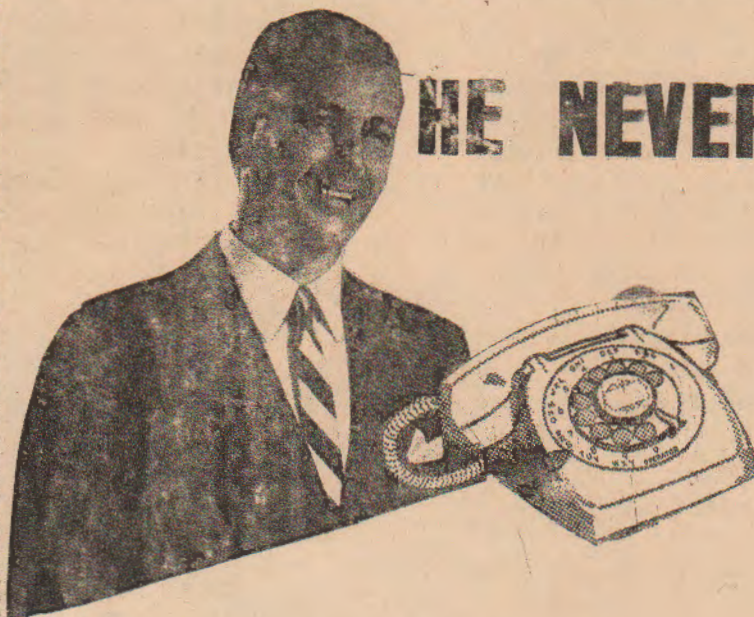

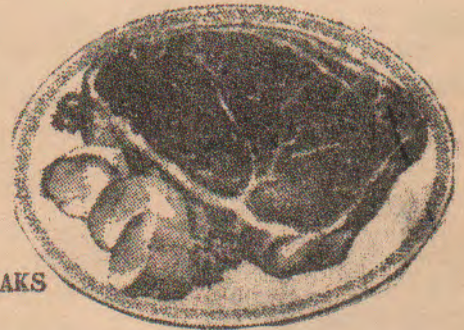

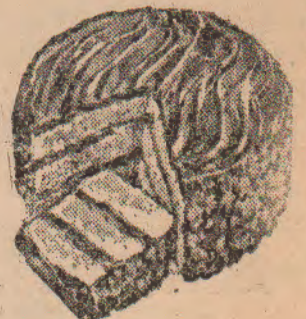
