### PEDESTRIAN KILLED WHEN STRUCK BY CAR

**PETERS CREEK:** Two pedestrians were hit by a car at Mile 22 3/4 on the Glenn Highway, with one killed and the other seriously injured.

Dead is David Golley, age 20, of Anchorage. Suffering serious injuries and taken to Providence Hospital by the Chugiak ambulance. She was suffering from a fractured pelvis, fractures of the arm leg and numerous internal injuries.

ANCHORAGE: Little information was available concerning a conference which took place between a group of Chugiak High School parents and the Anchorage borough school administration last Monday afternoon.

The parents had apparently called for the conference with Dr. Don Hartman of the administration to list a number of problems which they felt existed at the high school.

One of the main items was the belief of some parents that seventh graders should not be attending the same school as senior high school students.

Dr. Hartman pointed out that if one or more of the local elementary schools wanted to keep the seventh grade at an elementary school level, the school administration would be agreeable to this.

Also brought up was the fact that students are permitted to smoke on the school grounds at Chugiak High. Dr. Hartman referred this problem back to the local level, saying that the principals of each high school in the borough had the discretion of permitting or prohibiting smoking on school property as he saw fit.

EAGLE RIVER: No new information was brought forth at a meeting of the steering committee which had been charged with exploring all options toward local government that are open to the Greater Chugiak Area.

The committee had been formed last year and members had been assigned the task of researching each of the five options open and returning with a complete list of facts which was then to be presented to local residents at a public meeting.

The steering committee met last Sunday at 5pm at the Owl Cafe in Eagle River, and presented their reports.

The options open were listed as STATUS QUO (no change from things as they exist). SERVICE DISTRICT (with a board of supervisors similar to the Chugiak Fire Service District). WITHDRAWING AND JOINT THE MAT-SU BOROUGH.


INCORPORATING AS A CITY (1st or 2nd class). WITHDRAWING FROM THE ANCHORAGE BOROUGH AND FORMING A NEW BOROUGH.

Several attending the meeting felt that the committee had unearthed no new information, and that the facts and figures used for reference were outdated.

It was recommended that an effort be made to get the latest figures before a public meeting is called.

### COMMERCIAL HARVEST OF CLAMS NOW PERMITTED

**JUNEAU:** Frederick McGinnis, Commissioner of the Department of Health and Social Services, announces that the commercial harvest of razor clams for INTRASTATE commerce is now permitted at Polly Creek Beach which is on the west shore of Cook Inlet from Redoubt Point south to the mouth of the Grecian River (Coast and Geodetic Chart No. 8553).

Polly Creek Beach has been closed due to Insanitary conditions found in June 1972.

Resurveys of the area have determined that the bacteria levels are now at a satisfactory level and at present, there is no continuing source of surface pollution from human wastes.

The other approved commercial harvest areas of Swikshak and Cordova Prince William sound continue to be open and are unaffected by this action.

## Contributions Can Reduce Federal Taxes

The Internal Revenue Service points out that charitable contributions to qualified organizations are tax deductible if you itemize deductions on the Form 1040 income tax return.

Charities, churches, nonprofit schools and hospitals, as well as certain war veterans groups may be qualified organizations. And still other groups may qualify.

In general, you can deduct contributions to qualified charities in amounts up to 50 percents of your adjusted gross income. You also can deduct payments to churches, synagogues or other religious organizations in the form of dues, fees, pew rents or assessments.

But you can't deduct as charitable contributions any dues, gifts or contributions you make to civic leagues, social clubs, international organizations, business leagues, or labor unions.

The IRS said that of the five tests that taxpayers must meet to satisfy the legal requirements for claiming another person as a dependent, the one taxpayers find most difficult is the support test.

To satisfy the support test, you must show what it cost to support your dependents for the year, and how much of this you provided. It's naturally more difficult to gather such records for a child who does not live at home, or for a parent or another relative in another city, than it is for dependents living with taxpayers.

Close relatives including children, grandchildren, brothers, sisters, parents, grandparents, and aunts and uncles do not have to live with you to qualify as dependents.

You can obtain additional information free of charge by sending a post card to your local IRS Office, requesting Publication 501, "Your Exemptions and Exemptions for Dependents."
